PHILANTHROPIC PROJECT

Chairman's Report to Grand Chapter 2004-2005

Companions, we can be very proud of our accomplishments of the past twenty-three or four years. From a humble beginning we have collectively put together \$85,000.00 in Guaranteed Investment Certificates. We have donated \$73,600.00 to Charity and still have our \$85,000.00 investment.

Much of our success has been in the High interest rates between 1980 and 1995. Now we must accept the future for what it will bring. From the heights of 15% or 16% in the early eighties to the present, our interest rates have slowly declined to just under 4% in 2005.

We would require \$100,000.00 at 4% to return \$4,000.00 for a Charity of our choice. However, let's all enjoy what we can do and give what we have to give. The interest from 2004 will allow us to give \$4,000.00 to charity in 2005, but the interest return for 2005 will be down over \$700.00, so we will be looking at a figure of \$3,500.00 in 2006.

Looking back at our humble beginning, we started out to raise \$10,800.00 that would be invested at 15% at that time and return \$1620.00 annually for charity. This same investment figure would return \$432.00 for charity at 4%.

We should all be justifiably proud of the Companions and our Friends who have continued to add tax paid dollars to our ever increasing Principal. Keeping an eye on the future, let's look forward to the day when our investments exceed \$100,000.00, the interest rate returns to 5% and we will be able to give \$5,000.00 to a charity of our choice..

I missed the Royal Arch Degree but I am certain it was equally well done. Any auspicious occasion in this Chapter results in a banquet prior to the meeting..

Eureka Chapter #15 is struggling with a very small resident membership. They are in the process of deciding the future of their Chapter but no decision will be made until after this Grand Chapter. I really enjoyed the fish fry this Chapter had when the Grand First Principal made his official visit.

Masonic Education is submitted in some Chapter notices; this is a great way to receive information of what fellow Companions are doing in Chapter for those who are unable to get out to their meetings. I also want to congratulate Chapters that have collected monies to send to relief projects like Tsunami.

Some Chapters have had functions for their Companions like BBQ's; this is a good idea for Fellowship. Membership is always an ongoing problem. Some are struggling and others holding their own. Companions, Freemasonry has through the ages, been subjected to criticism but has survived through good and bad times. My Lodge Shiloh #70 is amalgamating with Starbuck 160. Some Brethren have demitted but the nucleus that want to be a Mason of a Lodge will continue to be a member. Lodges are now further apart from one another. In closing M E Sir, it is the custom of the Grand "J" at this Convocation to recommend the rank of Past Grand Superintendent upon R E C Fred Magerl, District 1 and R E C Lend Pritchard, District 2. .

REPORT OF THE GRAND HISTORIAN

R Ex Comp Trevor Lambert, Grand Historian

Most Excellent Sir and Companions

Over the last year, research has continued the direction of previous years. The particular direction this year has been the very earliest years of The Holy Royal Arch Masonry of Manitoba. This is a natural extension backwards to previous reports that covered the period of about 1890 to 1923. Naturally, this period involves only Prince Rupert's Chapter #52 (Grand Chapter of Canada) later #1 of the Grand Chapter of Manitoba in Winnipeg. Unfortunately I have not had the opportunity to examine any early surviving records of the illustrious Chapter, so these remarks are based upon the records of the Grand Chapter of Canada.

The process began with a report by Grand "Z" M E Comp T Douglas Harington to the 15th Assembly of the Grand Chapter of Canada held in the Masonic Hall in Toronto on 14 August 1872.

"I have granted dispensation for the following Chapters during the past year, and which I recommend Grand Chapter to confirm by Warrant viz: ... Prince Rupert's ... Winnipeg.

... And here it will not be out of place to state that your Grand Treasurer R E Comp Noel, have left to become a resident of Manitoba delivered over his books and papers ... R E Comp John V Noel, I have nominated Grand Superintendent of Manitoba as a token of recognition and appreciate of his services to Grand Chapter"

R E Comp John V Noel, Grand Superintendent, in his report on the Manitoba District stated: in the aforementioned Assembly "In the beginning of July, I had much pleasure, assisted by E Comps Spencer and Henderson in opening a Chapter to be called "Prince Rupert's Chapter" on which quite a number of petitions were received, a subsequent meeting balloted and accepted, a proof that Royal Arch Masonry will flourish in this province. I also had the pleasure, with the aid of the above mentioned Companions, of installing the Principal Officers of this Chapter"

The Executive Committee of 1872 "...recommend that warrant be granted by the Grand Chapter to...". Prince Rupert's Chapter U D and the number 52 was granted to this new Chapter. Prince Rupert's Chapter reported a membership of 9 members in 1872.

There wasn't a report on Prince Rupert's Chapter in 1873 and 1874. In 1874 R E Comp James Henderson, Grand Superintendent, Manitoba District reported that "Capitular Masonry has not been as prosperous in this province during the past year as we expected, owing to so few Companions in the Province. But from the number of Companions added to the total, I fell confident that Prince Rupert's Chapter, the only one in the province, will soon be in a prosperous condition"

In 1887, John K Brydon reported the Royal Arch Masons in the District to be flourishing with the admission of 31 new members. Prince Rupert's Chapter 52 reported a membership of 106, average attendance of 33 and the purchase of new banners for a cost of \$190.

Prince Rupert continued to flourish and slightly later was joined in the District by Keystone Chapter #99 in the 1890's. Both of these Chapters continue to exist today despite all the difficulties that have occurred.

By perseverance we will not be easily discouraged by obstacles, but will stay the course.

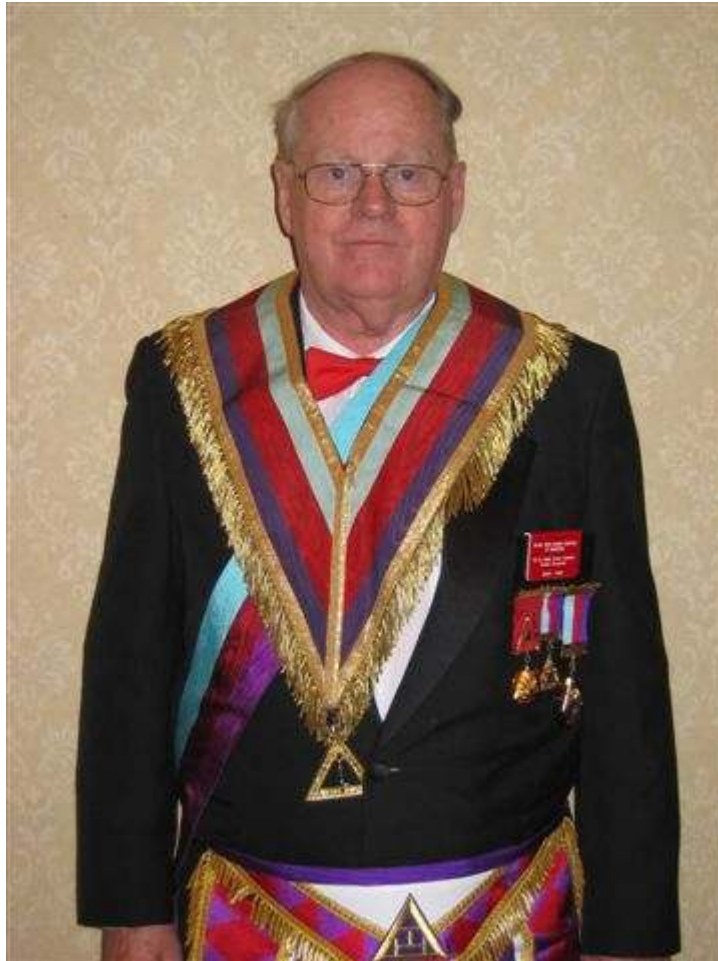
By prudence we will weight our options, test and review plan implementation and evaluate results.
