Companions, as the years move by and Grand First Principals pass away, this Grand Chapter loses more that a Grand Z - they lose a friend. It is my duty to tell you of two friends who have toiled in the quarries of Freemasonry and who have passed to the Grand Chapter above during the past year.

*ROBERT W. HOOPER  
29 July 1911 - 5 May 2006*

Companion Hooper was the second of ten children born to Robert and Anna Hooper at Woodside, Manitoba. He served overseas in England, Belgium, France, Holland and Germany with the armed forces during World War II and on returning home in February 1946, he resumed employment with the Canadian Pacific Railway until his retirement in 1976 having served as Road Master for several years. That is where I first knew Companion Bob Hooper, as I worked a few summers with my Dad on the railway. My Dad told me that he knew Companion Hooper as a fair man, and that was good enough for me.

Masonically, Most Excellent Companion Hooper was raised in Acacia Lodge No 111 in 1954 and served as Worshipful Master of Binscarth Lodge No 101 in 1968. He affiliated with Transcona Lodge #123 where his son Robert, also has served as Worshipful Master.

He was exalted to the Holy Royal Arch in King Edward Chapter #4 in Neepawa in 1961 and served as First Principal in 1970. He affiliated with Transcona Chapter #16 and was First Principal in 1980. Bob was elected and served as Grand First Principal of this jurisdiction in 1983-1984. He was also a member of the High Priesthood of Manitoba.

He was consecrated a Knight Templar in Mount Carmel Preceptory #44 in 1966 and served a Preceptor in 1969.

He was a member of Khartum Temple, a member of the Order of the Eastern Star, and he was a Life Member of the Elmwood Legion.

*JAMES (SCOTTY) RUSSELL  
5 APRIL 1920 - 26 FEBRUARY 2007*

Companion Russell was born on a farm south of Brandon to James and Nettie Russell and lived his early years in Rivers. He grew up in a country setting and shared his parent's love of music as he played the accordion, violin and harmonica.

Companion Russell also served his Country as he joined the Canadian Army in October 1941 and served on the East Coast of Canada and in the United Kingdom until he was discharged in September 1946.

Following the war, he began employment with the Department of National Defense at CFB Rivers. There he became a stationary engineer and eventually spent many years working at the Deer Lodge Centre in Winnipeg until his retirement in 1977.

Masonically, Companion Russell was raised in Rivers Lodge #115 in December 1953 and served as Worshipful Master in 1962. He was exalted in Mount Sinai Chapter #8 in June 1954 and served as First Principal in 1960. He was appointed Grand Master of the First Veil in 1966, elected Grand Third Principal, Grand Second Principal and then Grand First Principal, serving this Grand Chapter in 1969-1970. I read that one of his proudest achievements was his involvement with Royal Arch Masonry for 50 years.

Companion Jim was a member of Brandon Council #10, Royal and Select Masters, Brandon Preceptory #74, Order of the High Priesthood in Saskatchewan, Khartum Temple, and the Order of the Eastern Star. He was a member of the Royal Canadian Legion, Branch #75 in Rivers.

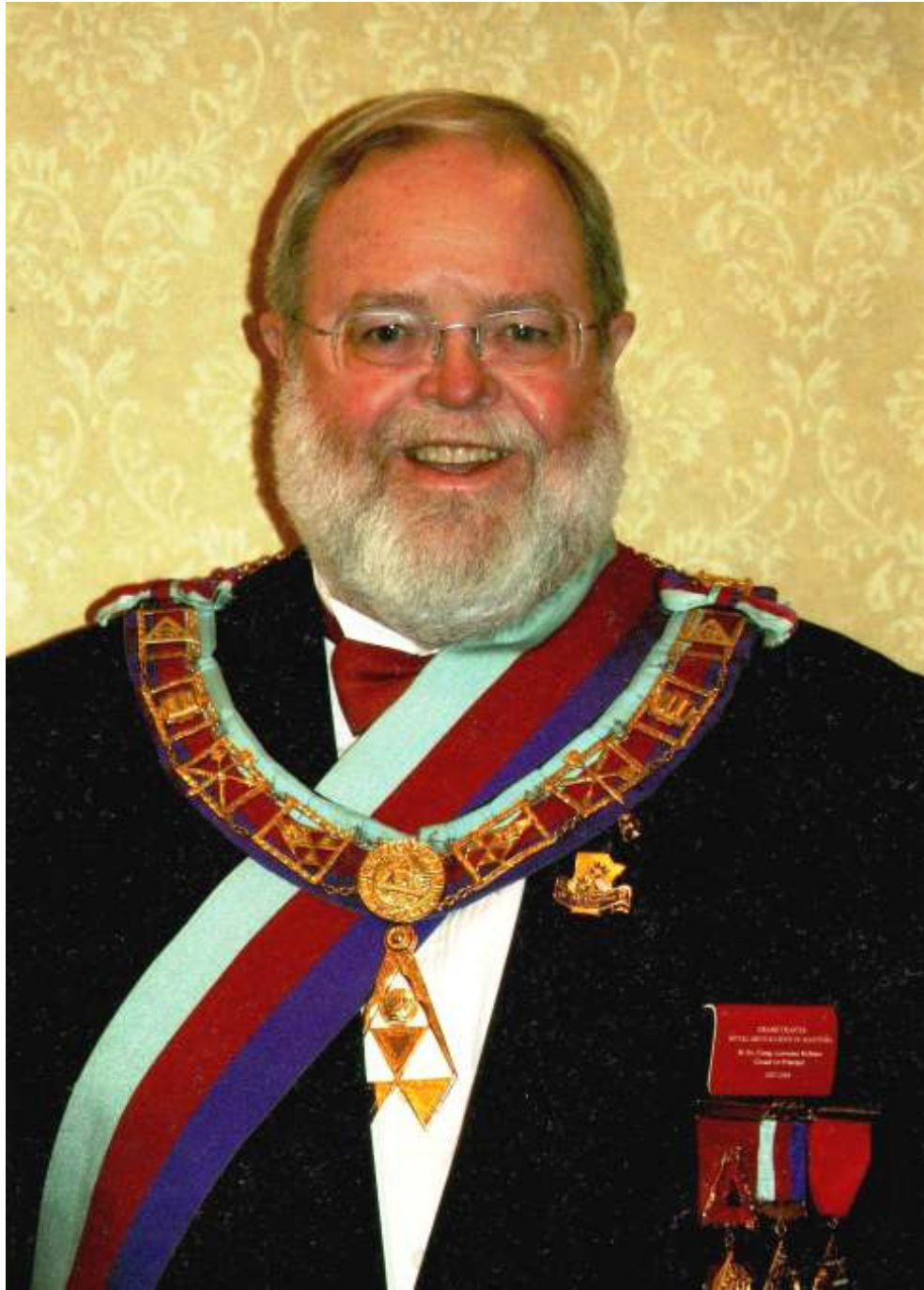
