As Lieutenant Governor of Manitoba I spend a good portion of each day in a building that embodies Masonic philosophy through art and architecture.

Manitoba's Legislative Building is a place of symbols and metaphors that bring to mind timeless wisdom from Egypt, Greece, and the Bible. Even the proportions of the building echo ancient ideas of harmony and beauty.

So it gives me pleasure to join a group of Manitobans this evening who are dedicated to maintaining a living connection to traditions of wisdom passed down through history.

Manitoba, as you know, has traditionally been referred to as the Keystone province. As Royal Arch Masons, you all know the role of the keystone in an arch – it's the stone that holds the arch together, uniting the two sides in one strong and beautiful structure.

That has always been Manitoba's role within Canada. Our province famously unites east and west. Through our port of Churchill, we also unite north and south.

## **REPORT OF THE GRAND HISTORIAN 2009- 2010**

Most Excellent Companion Vic Bryll, Grand First Principal, Companions all-

After much deliberation over the course of the past year, and with the approval of this Grand Chapter, I am well on the way to depositing the history of the Grand Chapter in the hands of the Manitoba Archives for safe keeping. After sorting through documents and proceedings back to 1923 to the beginning of the Grand Chapter of Manitoba, and beyond those years back to 1890, I looked through quite a comprehensive history. Once it is placed, all information in the Archives will be available to anyone who wishes to look at it, and as the Grand Historian, I will be maintaining a set of Grand Chapter proceedings for local reference. As you saw at the desk when you registered, there were surplus copies of the proceedings of several past Grand Convocations. If you would like to have a copy of any of these proceedings, pick them up before the registration desk is closed, as after this convocation, all surplus copies will be recycled.

While going through these items, I looked through the proceedings of the Grand Chapter of Canada for 1910, 100 years ago. At that time, Manitoba was District 15 and consisted of 7 Chapters. (sound familiar) They were Prince Rupert Chapter 52 in Winnipeg, Keystone Chapter 99 in Portage la Prairie, Corinthian Chapter 101 in Boissevain, Avondale Chapter 156 in Hartney, Keystone Chapter 141 in Brandon, King Edward Chapter 136 in Neepawa and Rabboni Chapter which was under dispensation. Five of these Chapters are still in operation today. Annual dues were between \$2.00 and \$5.00 and the total Membership for the Manitoba District was 808. At the annual Convocation in Toronto in February 1910, the Grand Superintendent for the Manitoba District, R. Ex. Comp Ducker said in his final report, "The Capitular degrees will amply repay the most careful study, and, in my opinion, nothing more beautiful can be found in the whole structure of Freemasonry." I think this statement is applicable to this day.

This past year, we have lost two long serving Members and Past Grand First Principals of the Grand Chapter of Manitoba, and it is my duty and privilege to record their Masonic history here.

### **MOST EXCELLENT COMPANION WILFRED NELSON COTTON**

Most Excellent Companion Wilford Nelson Cotton – Grand First Principal 1967-1968 – was born on the farm at Kenville, on December 31, 1917. He received his education at Kenville and remained on the original family homestead, farming first with his father and brother, and then with his son. He enjoyed playing in all sports, especially enjoying curling and golfing. He was involved in his community, serving on the rink, hall, church and school boards for many years as well as the Swan Valley Agricultural Society for 44 years. In retirement, Companion Cotton lived in Swan River and in Weslaco, Texas during the winter months for 25 years.

Masonically, Most Excellent Companion Cotton was initiated into Freemasonry in 1947 in Prince Arthur Lodge in Swan River, serving as Worshipful Master in 1957. He was exalted in Royal Arch Masonry in Rabboni Chapter 7 in Dauphin on April 14, 1949. He became a charter Member of Wapiseew Chapter 18 in Swan River and served as the first Excellent First Principal. He was District Superintendent in 1953, serving the Grand line of Royal Arch Masonry and becoming Grand First Principal in 1967. He was also a Member of Brandon Council Royal and Select Masters and Mount Carmel Preceptery #44. He was also a Member of Khartum Temple and was a charter Member of the Swan River and District Shrine Club and was a Past Patron of Washakada Chapter 19 of the Order of the Eastern Star.

Most Excellent Companion Cotton passed to the Grand Chapter above one year ago on April 26, 2009, and is survived by Sheila, his wife of 68 years and her family.

### **MOST EXCELLENT COMPANION GORDON ALEXANDER EBEL**

Most Excellent Companion Gordon Alexander Ebel – Grand First Principal 1992-1993 was born March 9, 1928 in Stratford, Ontario. After his schooling, he joined the Royal Canadian Air Force in 1946 at 18 years and remained in service until June 1979 at which time he retired and returned to Portage la Prairie and worked at the Manitoba Developmental Centre as Safety Officer for 10 years. He was interested in all sports and Mrs. Ebel's little boy curly, as I remember him calling himself, enjoyed playing hockey and baseball. Gordon enjoyed making diamond willow canes, and was happy to share them, as many people have been recipients of one of his special canes. Gordon and Helen enjoyed RV'ing and spent many happy times with friends camping in places all across Canada and the United States. When you talked to Gord, he always had a joke or a story to tell you.

Most Excellent Companion Ebel was initiated in Lebanon Lodge in Exeter, Ontario in September 1960 and Royal Arch Masonry in Godrich in 1967. Upon moving to Manitoba, he affiliated with Marquette Lodge and Gothic Temple Lodge, serving both lodges as the Worshipful Master and then affiliating with Assiniboine Lodge. He was District Deputy Grand Master for District #2 in 1992. He became a Member of Keystone Chapter 2, Royal Arch Masons and served this Grand Chapter as Grand First Principal in 1993-1994. He continued to serve in several other offices and at the time of his passing was still very actively involved. Gordon was also a Member of the Cryptic Rite Masons and was the Grand Master of Western Canada, Royal and Select Masters in 2005. He was a Member of Mount Carmel Preceptery and was the Provincial Grand Prior for District 8 – Manitoba/North-West Ontario. Most Excellent

Companion Ebel was a Past Grand Governor of the York Rite College as well as a Member of the Order of the High Priesthood and the Knights of the York Cross of Honour, and the Red Cross of Constantine. He was also a recipient of the Order of the Purple Cross. Gordon served the Grand Chapter of the Order of the Eastern Star as Worth Grand Patron for Manitoba and just completed his duties last May. Gordon was a very active Member of all the York Rite bodies of Masonry for 50 years and was a highly respected Member of the Craft.

He was also a proud Member of the Royal Canadian Legion.

Most Excellent Companion Ebel will be lovingly remembered by Helen, his wife of 59 years, and her family.

After a short illness, he passed away on February 16, 2010 at the age of 81 years in Portage la Prairie.

With our Companions, it was always, "Happy to Meet" "Sorry to Part" and soon it will be "Happy to Meet" again

In his New Year's message at the beginning of the Second World War, King George said, "I said to the man at the gate of the year, "Give me a light that I may go forth into the unknown." And the man replied, "Put your hand into the hand of God. That shall be to you better than a light, safer than a known way."
